Facilities Updates

The shade structure is up at Seaside. One final adjustment is needed: There is a slight difference in levels between the newly poured concrete and the existing patio pads. This creates a tripping hazard. The matter will be brought up with Troon.

The windsock at Seaside has come off its pole. Board members will work with Troon to get this matter resolved.

The dink practice board is up but needs to be adjusted to come out at a slight angle from the wall. This will give the ball more bounce and help lower the noise level. Board members will work with Troon to get this matter resolved.

New facility requests

Three new requests are being added to the list that's been given to Troon:

- Fold down benches to be installed in the restrooms at Rymer so when people overheat, they have a place to sit while cooling down.
- A windscreen to be installed at Rymer to block the glare off the cars in the parking lot.
- Fans to be installed at Rymer and Seaside to keep things cooler and keep the bugs away. Power would be run from the lights.
